ANNUAL FEES/PAYMENTS:

Registration Fee (Yearly): \$250

Material Fee (Yearly): \$250

Deposit (Yearly): Last month of tuition dependent of program

TUITION & PAYMENT OPTIONS:

- The yearly tuition can be broken into 10 equal installments (September to June).
- Tuition can be paid in one annual payment. There is a **2.5% discount** when the annual tuition is paid in full by the beginning of the school year (September).
- Monthly tuition must be paid in advance and can be paid by the 1st of each month. Dandelions Montessori does NOT prorate months. Payment is accepted by cash, Venmo, check, or direct deposit. Payment is due regardless of attendance.

Fees due upon enrollment:

- In order to secure your child's space, advance payment of the registration fee (\$250) is required provided all provisions in the Agreement contract and the Admission Policies are met. The registration fee is non-refundable.
- Material Fee (Yearly): \$250 (non-refundable).
- Deposit of the last month tuition.

Other Fees

- Late departures will be charged \$1.00 for every minute past scheduled pick-up time. An invoice will be provided at the end of each week.

Other charges:

- Due to cost-of-living increases, all schoolhouse fees are subject to change from one school year to the next. A 30-day advance notice will be given prior to any rate change.

Discounts

There is a **5% sibling discount** for the second child in a household enrolled concurrently and for all additional siblings. The discount will be taken off the lesser rate of the siblings.

Low-income Discount

To be eligible, the total household gross income must be equal to or lower than the levels shown in the table below:
