ANNUAL FEES & PAYMENT

Registration Fee (Yearly): \$250 (non-refundable).

Material Fee (Yearly): \$250 (non-refundable).

A DEPOSIT comprising the registration fee (\$250) and the last month of tuition is required to secure your child's space, provided all provisions in the Agreement contract and the Admission Policies are met. The registration fee is non-refundable.

The yearly tuition can be broken into 10 equal installments (September to June).

Tuition can be paid in one annual payment. There is a 2.5% discount when the annual tuition is paid in full by the beginning of the school year (September).

The material fee is due in full with the first tuition installment.

Monthly tuition must be paid in advance by the 1st of each month. Dandelions Montessori does NOT prorate months. Payment is accepted by cash, Venmo, check, or direct deposit. Payment is due regardless of attendance

Other Fees

Late departures will be charged \$1.00 for every minute past the scheduled pick-up time. An invoice will be provided at the end of each week.

Other charges:

Due to cost-of-living increases, all rates are subject to change from one school year to the next. A 30-day advance notice will be given before any rate change.

Discounts

There is a 5% sibling discount for the second child in a household enrolled concurrently and for all additional siblings. The discount will be taken off the lesser rate of the siblings.

Low-income Discount
